Grounds at the racecourse have numbers on the pitches: from the entrance in Douglas Street they are numbered 1 to 5 in a clockwise direction, No 1 being on the left as you enter and No 5 on the right, inside the trotting track.

At UNE's Consett Davis ground, pitches are numbered from the eastern (practice nets) and (No 1) towards the west (No 3, malthoid surface).

At the schools, Oswald Oval is in the main school area at O'Connor, De Moulin is in Canambe St; TAS Meadowfield is on the corner of Grafton Rd and Canambe St, Wakefield is on Grafton Rd and Chapel St, Frontfield is on Grafton Rd and Douglas St, Backfield is approached through the Brown St entrance.

At the CAE, Moran is in Taylor St (gravel section), Newling 1 (turf) and 2 (malthoid) are entered from Taylor St.

Sprigs are suitable only on the turf wickets, which are Bellevue, Consett Davis 1, Consett Davis 2, Harris Park, Lambert Park, TAS Backfield, Newling 1. Mats are provided at Hillgrove, Bruce Browning Park, TAS Wakefield, O'Connor Oswald, Uralla. All other grounds are concrete, generally without malthoid.

The large number of teams has necessitated the full use of all available grounds. On many occasions school grounds at O'Connor, Armidale High and TAS have had to be allocated to outsiders who are asked to respond to the hospitality of the schools in a fitting manner. By this means, Sunday games have been avoided.
